Back-to-School for the 2025-2026 School Year

The 2025-2026 school year starts on **Monday, August 18, 2025**. It will be the first full day of classes for all students, and we look forward to seeing you. Please use this guide to prepare for the new school year, and have a safe and happy summer!

2025-2026 Minimum Health Requirements

Evidence shows that healthy students have better attendance patterns and perform better academically. The State of Illinois requires parents/guardians to provide proof that their child has received their required immunizations and school physical exam before **October 15, 2025**, or their child will face exclusion from school. For more information about CPS health requirements, contact your School Nurse.

Physical Examination – Due upon enrollment or no later than October 15, 2025.

Must be completed within 12 months before entering: PE/PK, Kindergarten, 6th Grade, and 9th Grade, or whichever grade the student is in if they are entering CPS for the first time.

Vision Examination – Due upon enrollment or no later than October 15, 2025 for students who are:

- Entering the State of Illinois public school system for the first time at any grade level
- Entering Kindergarten

Dental Examination – Due by May 15, 2025 for students in Kindergarten, 2nd Grade, 6th Grade, and 9th Grade.

Immunization Requirements – Many children missed check-ups and recommended childhood vaccinations during the COVID-19 pandemic. Making sure your child is up-to-date with their vaccinations is the best way to protect them from a variety of vaccine-preventable diseases. Vaccines for the following illnesses are required at time of enrollment (or no later than 10/15/25) by the State of Illinois for students unless an Illinois Certificate of Religious Exemption Form is received: Diphtheria, Pertussis, Tetanus Polio; Measles, Mumps, Rubella; Haemophilus influenzae type b (Hib); Invasive Pneumococcal Disease (PCV); Hepatitis B; Chickenpox; Meningococcal Disease.

2025 Summer School Session

Summer Safety Tips

If you have questions about which vaccines are best for you or your child, CPS recommends that you talk to your doctor who knows your health history.

Parents should know where their children are at all times!

Do not swim in areas that do not have a lifeguard on duty.

Prolonged exposure to the sun can be harmful. Children should dress appropriately and not be exposed to the sun for long periods of time.

Students are encouraged to travel together in pairs whenever possible.

If a student feels uncomfortable or threatened in any way, they should go to the nearest business or populated area and call for help.

While having a phone can help in a crisis, students should use phones with good judgment and be aware of their surroundings.

Students should report any suspicious vehicles, persons or behavior to the police or a trusted adult.
